Re: Arborist recommendations for tree pruning at Lot 9 UBC.

Diamond Head Consulting Ltd. (DHC) was asked by Polygon Homes to review the proximity of a few trees in relation to the crane movement located on Lot 8 at UBC. The issue is that several of the branches from the nearby trees are interfering with the cables/chain attached the crane as it lowers materials to the lower floors of the development.




Figure 1 Southern boundary of trees that were retained at Lot 8. A few of these trees require pruning and one is proposed for removal.


Those trees requiring some type of treatment consisting of lift pruning, tilting back branches or removal are summarized below in **Error! Reference source not found.**.

Table 1. Inventory of identified trees and new pruning/treatment comments.

Тад	Species	DBH	Height	Condition	Comments	Pruning Recommendations
2620	Cedar (T. plicata)	76	28	Moderate	Much of the live crown is still present. This tree has about an 70% live crown.	Remove lower branches. Can raise canopy by 3 meters. Follow ANSI 300 standards.
2579	Maple (A. macrophyllum)	15	13	Poor- Moderate	Suppressed. Tree has had much of its live crown removed by the crane movements.	Remove this tree. It has little live crown left and through pruning it, the tree will need to be topped.
2515	Maple (A. macrophyllum)	23	16	Moderate	Suppressed by adjacent trees. Has had some of its foliage remove. Can tilt back.	Crown raise by approximately 3 meters. Attempt to remove only the branches that are being impacted and leave enough to maintain its health. Follow ANSI 300 standards.
761	Maple (A. macrophyllum)	50	22	Moderate	Has had some of its foliage already removed.	Crown raise by approximately 3 meters. Follow ANSI 300 standards.
