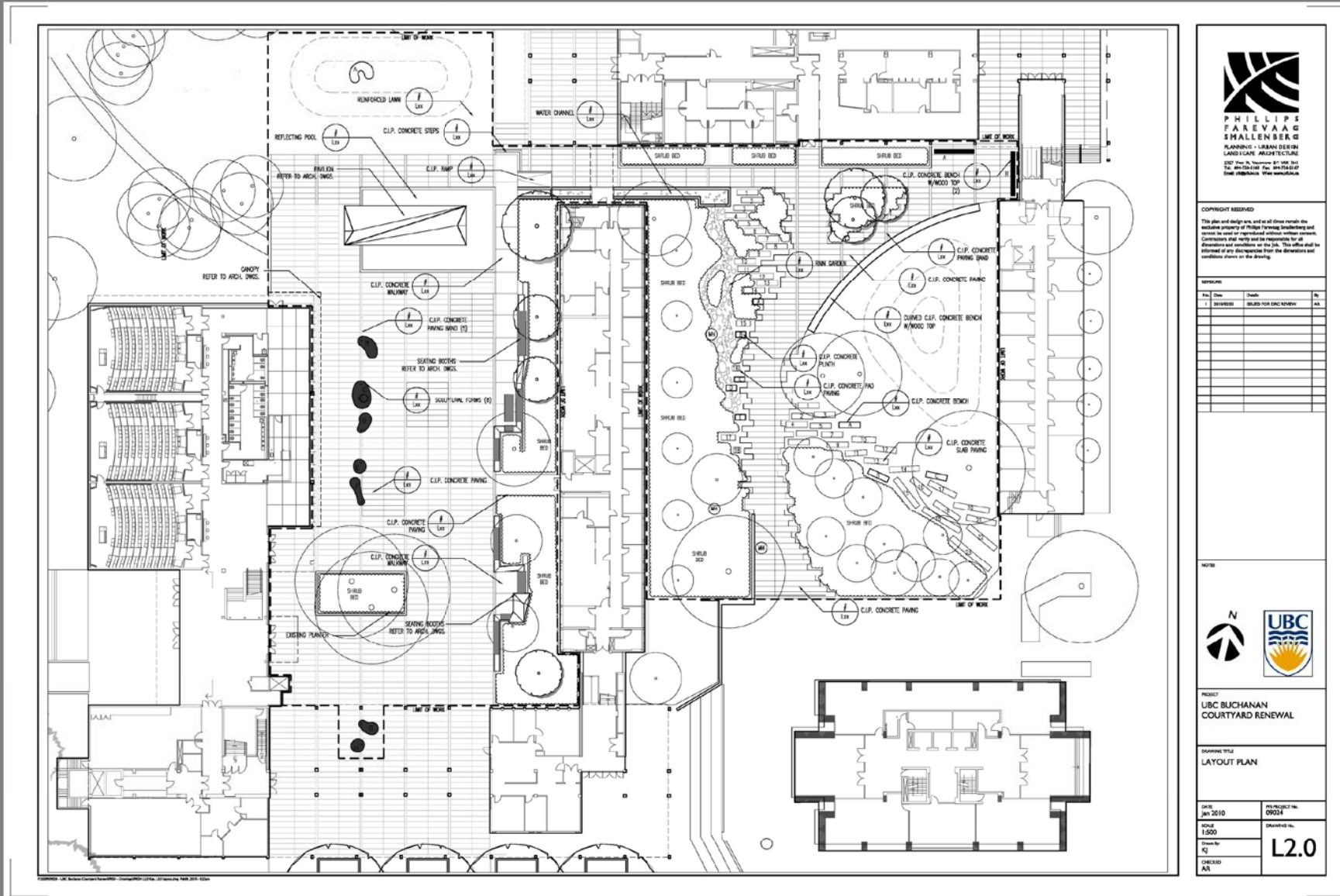

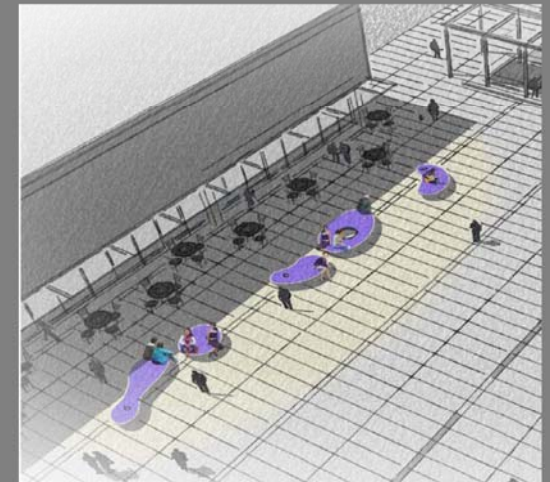
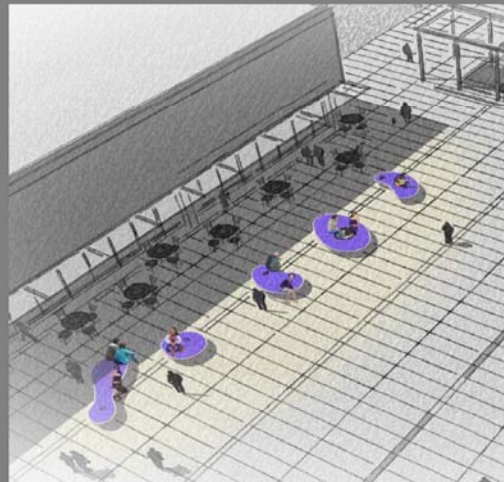
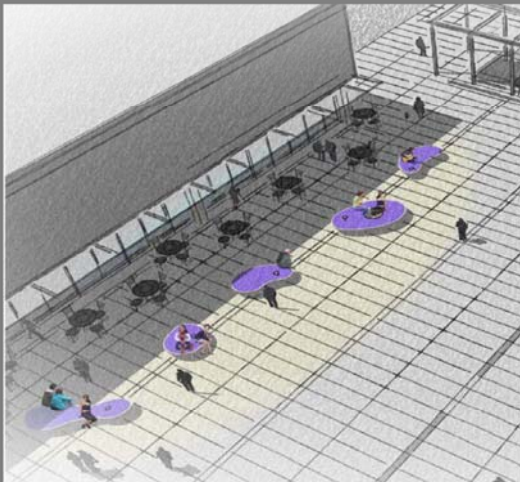
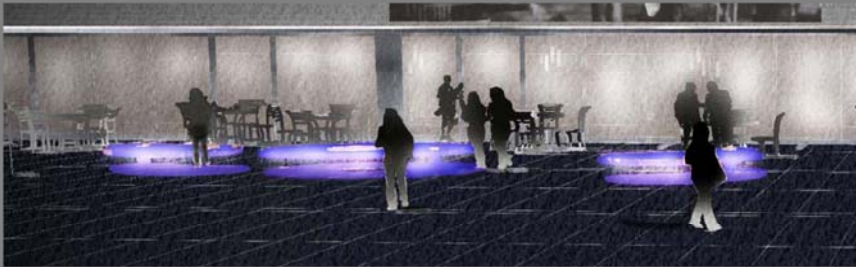
Stormwater management

- Stormwater collected from hard courtyard surfaces and adjacent building roofs
- Water conveyed via water channel to Rain garden
- Water filtered via Rain garden plant material
- Water collected in Rain garden via underground pipe matrix and pumped to cistern located under the pavilion
- Cistern water used for reflecting pool recharge and landscape irrigation
- Excess water in Rain Garden infiltrates into groundwater table



Sculptural forms

- Multifunctional as seats, tables, art displays, performance spaces
- Polycarbonate sheet on steel plate
- Rotatable post
- Lit for night feature
- Robust construction in response to anticipated frequent and potentially aggressive use, as well as longevity requirement

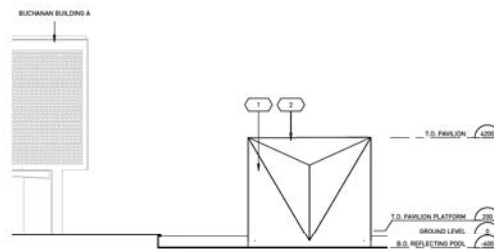
1 PAVILION NORTH ELEVATION

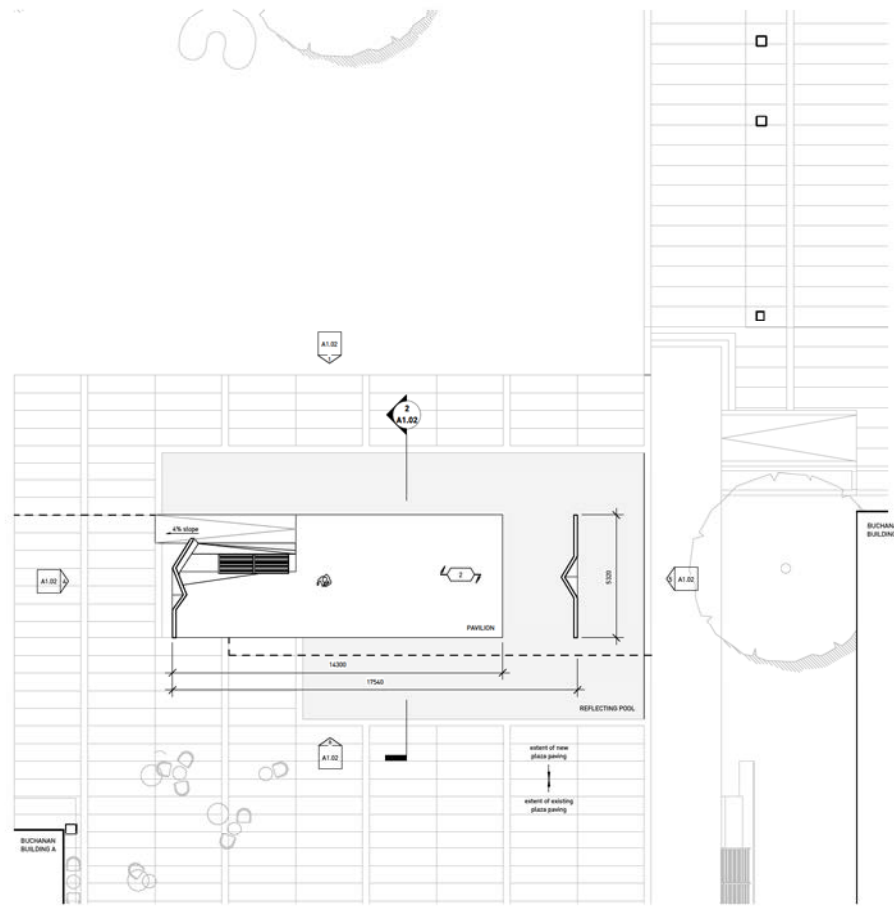
2 PAVILION CROSS SECTION

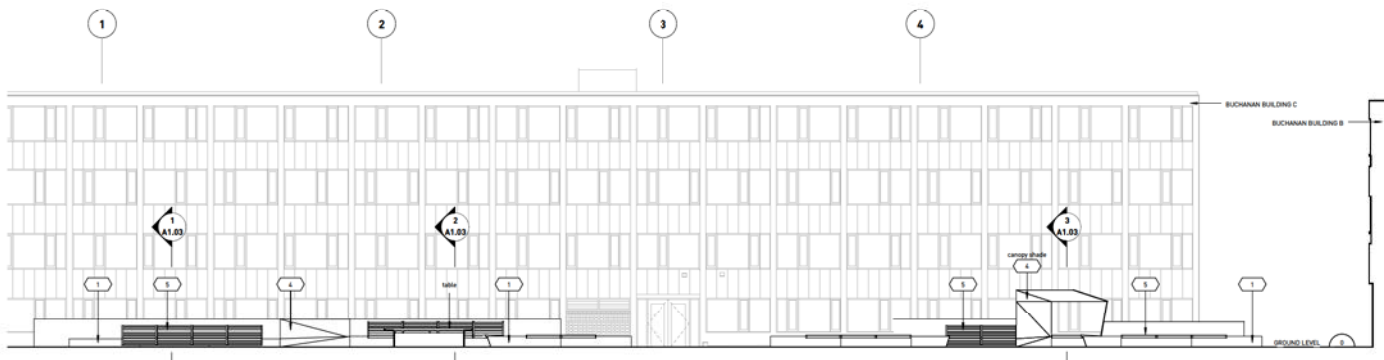
1 BENCH CROSS SECTION - AT RECLINER

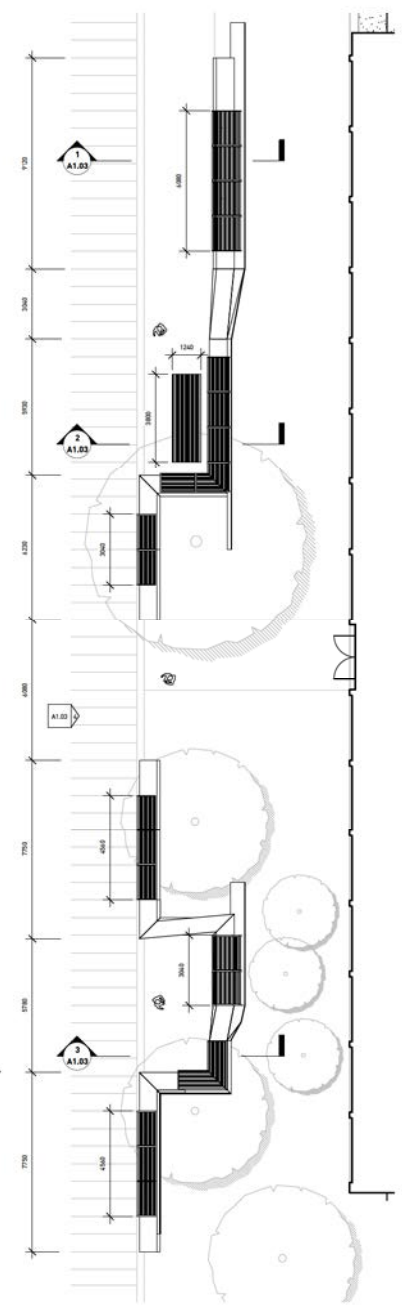
2 BENCH CROSS SECTION - AT TABLE

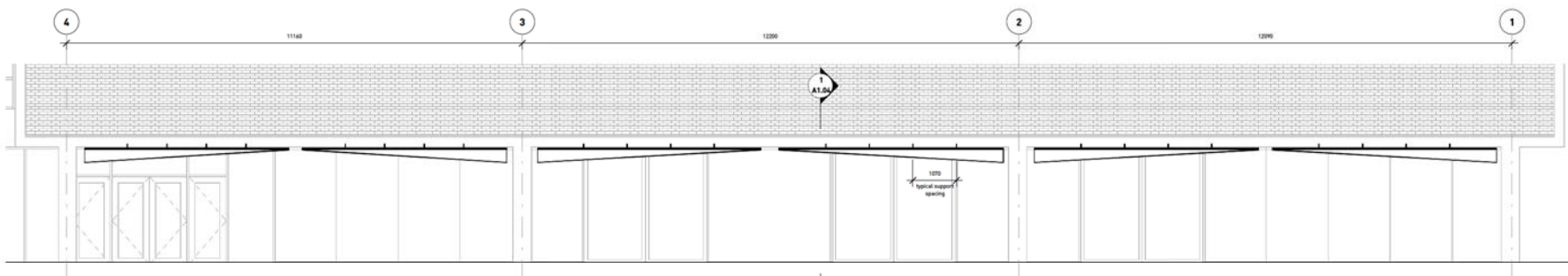
1 TYPICAL SECTION THROUGH BUILDING CANOPY
