1. Introductions	 Lia to act as interim Chair until one is selected Agreed unanimously. Review the Agenda Adopted unanimously. Committee member introductions Many members like the vibrancy and walkability of Wesbrook, it's park network, connection to nature, convenience to the campus and uniqueness as a special place. Many members expressed their interest in helping to shape the future of Wesbrook, sharing their voice, and supporting an inclusive planning process. Some members expressed interest in sustainability, public and active transportation and ensuring those principles show up in the Wesbrook Place South plan area. Some members shared their hopes that the plan update fits the needs of the people in Wesbrook. Some members expressed concern about the speed of development in Wesbrook and its impacts on quality of life and green space. 	
2. Planning Advisory Committee Terms of Reference	 Review: Planning Advisory Committee Terms of Reference C+CP Staff delivered a presentation and walked through key sections of the document, which was made available to meeting participants. The PAC is one part of a larger planning process. The purpose of the PAC is to provide input into the planning process. The PAC may see materials before they are available to the public, and may have the opportunity to provide feedback before things are finalized. Consensus is not the goal of the PAC - one purpose of having diverse membership is to surface different views and perspectives. Roles and responsibilities: Members representing organizations (i.e. AMS, GSS, UNA) are to share the views and perspective of that organization, at large members are to share their personal views and perspectives. Code of conduct: this group will not disseminate materials that are shared before they are publicly available. Minutes, which will be publicly available, will protect committee members privacy by excluding names/initials and any personal stories that may be 	



other key policy inputs

- Wesbrook Place South update will be guided by Campus Vision 2050's Six Big Ideas, conceptual layouts for the area, and what was heard through engagement. <u>Campus Vision 2050</u> was approved by the UBC Board of Governors in 2023.
- The UBC Land Use Plan (LUP) is the regulatory document that sets targets for amounts of housing, open spaces, building heights, etc. in neighbourhood areas. An updated LUP was approved by the Province in 2024.
- This plan update will also align with UBC's new Housing Action Plan (HAP) (approved by the UBC Board of Governors in 2023), UBC's academic mission, UBC's Neighbourhood Climate Action Plan (NCAP) (Approved by the UBC Board of Governors in 2024), and the emergent Integrated Rainwater Management Plan.

4. Project Terms of Reference

Review: Project Terms of Reference

C+CP staff delivered a presentation. Discussion throughout.

- Wesbrook Place South plan area will provide
 - homes for approximately 4,600 people which equates to about 2.1 million sq. ft. of new housing, delivered across a mixture of towers (up to 39 storeys) and midrise buildings (up to six storeys).
 - o about 30,000 sq. ft. of new ground-floor commercial and amenity space, including a local grocer
 - 1 new childcare facility
 - A new ecological park that preserves most of the site's existing large and healthy trees
 - An expanded rainwater management pond that is expanded and redesigned to be a public amenity
- This plan will conform to the LUP and will be approved by the UBC Board of Governors.
- The process is currently in the first phase. In this phase, preliminary directions are being explored. After engagement and technical work, staff will propose a draft plan. Once the draft is engaged upon, the final plan will seek Board of Governors approval.
- A rapid transit connection to UBC is part of TransLink's 10-year capital priorities.
